

**An Agreement
between
McHenry County College
and
The Board of Trustees of Illinois State University**

McHenry County College (MCC) and The Board of Trustees of Illinois State University (ISU) hereby form a cooperative relationship through this articulation agreement to better serve our public constituents, to smooth transfer, to minimize duplication of instruction, and to build on community college and university learning experiences. Both institutions recognize that working together, their collective efforts are stronger than their individual efforts.

The two institutions agree to the following:

1. MCC and ISU will collaborate and coordinate the recruitment and transfer of students in accordance with the program and degree requirements of their respective schools.
2. MCC will inform prospective students of this program during student recruiting activities through co-branded marketing materials and/or other mutually agreed upon means. MCC will publish the details of this agreement on their website for the benefit of students interested in participating in the program. ISU and MCC will jointly approve any and all advertising related to the Guaranteed Admission Program. ISU will provide online or print information regarding its academic program requirements and transfer credit policies.
3. Students who successfully complete the Associate in Arts Degree (AA) or Associate in Science (AS) degree (with IAI GECC noted on the transcript) at MCC, and meet all general ISU and program admission criteria, will be admitted to Illinois State University at the junior level.
4. Acceptance into the Elementary Education program at ISU is based on each individual transfer student meeting the conditions and considerations listed for that program. Specifically students successfully completing an AA or AS (with IAI GECC) degree at MCC and a minimum 3.0 cumulative GPA, will be admitted to the Elementary Education major at ISU.
 - a. If a student has attended multiple schools, the transfer GPA must be a 3.0 of all institutions attended using criteria from ISU Admissions.
 - b. Students must apply between the dates of September 1 and January 15 for fall admission into the major and matriculate the following August. Or for January admission, the student must apply between April 1 and August 1.
5. For the smoothest transfer, it is recommended that students follow the suggested "Recommended Elementary Transfer Guide McHenry County College to Illinois State University". (Exhibit A)
6. It is strongly recommended that students meet the minimum state licensure basic knowledge requirement. (E.g. acceptable licensure ACT or SAT or TAP score.) prior to transfer
7. This agreement does not guarantee admission for students seeking readmission or reinstatement to ISU.

8. The courses on the Recommended Elementary Transfer Guide should be completed by the time of transfer from MCC. Courses on this guide have been reviewed and accepted for transfer to ISU as part of the Elementary major.
9. Relationships between MCC and ISU faculty and administration are in the spirit of cooperation and provide the basis of this agreement.
10. Representatives of both institutions agree to meet on a regular basis, but at least biannually, to assess curricular changes and other conditions that may affect the nature of the agreement.
11. This agreement does not preclude either institution from making curriculum changes as it may solely deem appropriate in which case appropriate notice will be given to the operative academic personnel at the cooperating institution.
12. Subject to review and approval by both parties, appropriate publications and promotional materials regarding this agreement will be made available to all MCC students with interest.
13. Either ISU or MCC may terminate this agreement by giving one year's advance notice to the cooperating institution's president or academic vice president. All students admitted to ISU or enrolled at ISU at the time such termination became effective shall be permitted the opportunity to complete their degree or program upon such terms and conditions as were in effect at the time such student was admitted.
14. This Agreement will become effective upon signature by all parties, and will continue for a period of one (1) year, and will be automatically renewed for additional one (1) year terms for a total of five (5) years, unless earlier terminated in accordance with the terms hereof. The parties may mutually agree to renew and/or amend this Agreement. Any such renewal or amendment will be reduced to writing and signed by both parties.
15. It is understood and agreed that neither party to this Agreement shall be legally liable for any negligent or wrongful acts, either of commission or omission, of the others, unless such liability is imposed by law and this Agreement shall not be construed as seeking to either enlarge or diminish any obligation or duty owed by one party against the other or against third parties.
16. Both parties agree to comply with all applicable federal and state nondiscrimination, equal opportunity and affirmative action laws, orders and regulations. Neither party shall engage in unlawful discrimination or harassment against any person because of race, color, religion, sex, national origin, ancestry, age, marital status, disability, unfavorable discharge from the military, protective order status, or status as a disabled veteran or a veteran of the Vietnam era.
17. The relationship of each party to the other under this Agreement shall be that of independent contractor, and no employment, partnership or joint venture relationship shall be created by the entry into or performance of this Agreement by the parties.
18. Both parties affirm that, to the best of its knowledge, there exists no actual or potential conflict between such party's family, business, or financial interests and its obligations under this Agreement; and, in the event of change in either its private interests or obligations under this Agreement, and such party will raise to the other any questions regarding possible conflict of interest which may arise as a result of such change.

19. This Agreement may not be assigned by either party without the prior written consent of the other party. Such consent shall not be unreasonably withheld. This Agreement, attachments, and incorporated references shall constitute the entire agreement between the parties with respect to the subject matter hereof and supersedes all prior communications and writings with respect to the content of said Agreement. This Agreement may not be amended by either party unless such amendment is mutually acceptable to both parties, and is reduced to writing and signed by both parties.

20. The failure of either party to enforce any provision hereof shall not be construed as a waiver of such party's right to enforce such provisions in the future. In the event that any provision of the Agreement shall be held to be void, voidable or otherwise unenforceable, the remaining provisions shall remain in full force and effect. This Agreement shall be governed by the laws of the State of Illinois, without regard to the conflicts of laws. Any dispute arising hereunder shall be brought only in the federal or state courts located in Illinois, all protest based on jurisdiction or venue being hereby waived. This Agreement may be executed in counterparts, including by facsimile signature, each of which shall be deemed an original, and all of which together shall constitute a single instrument.

21. Any notice required hereunder shall be deemed given when delivered in person or three (3) days after being sent by first class mail to the following addresses, which may be changed by notice provided pursuant to this Agreement:
