**Student Exchange Agreement between  
Illinois State University and DongAh Broadcasting College**

Illinois State University and DongAh Broadcasting College, desiring to promote better understanding between Korea and the United States of America, to strengthen the relationship between the countries through higher education, and to improve the educational systems of both countries, believing that the expansion of mutually beneficial cooperation and exchanges will facilitate the achievement of these aims, hereby agree to the following terms and conditions of the Exchange Agreement

**Article I: Student Exchange**

**1 Number of Students**

- a Illinois State University will admit up to seven (7) new students per year from DongAh Broadcasting College into the bachelor's degree program in Communication either in the Mass Communication or Public Relations sequence
- b DongAh students will be admitted as transfer students under the Illinois Articulation Initiative (as described in Appendix A)
- c DongAh students enrolled at Illinois State University under this agreement must meet all graduation requirements of the university and the department of Communication in order to graduate
- d DongAh Broadcasting College will admit up to (10) students per semester from Illinois State University's department of Communication as non-degree students
- e The program of study to be undertaken by Illinois State University students at DongAh must be approved by chair of the department of Communication or his designee prior to departure
- f All approved courses for Illinois State students will be taught in English by DongAh faculty and/or visiting faculty from the department of Communication

**2 Selection of Students**

Illinois State University and DongAh Broadcasting College will each (and independently) recommend qualified students for admission at either institution. Each host institution will determine whether the recommended students are finally admissible. To be considered for admission, recommended students from either institution must meet the admission requirements of the receiving institution.

**3 Student Status**

- a Admitted students at either institution will be assigned an academic advisor at the host institution. Participating students from either institution will only enroll in courses approved by their academic advisor and so long as spaces are available.
- b Students must maintain a full-time student status as defined by the host institution.

#### 4 Finances

- a Participant's Academic Expenses Each participating student will be responsible for the payment in full to the host institution of his/her tuition, non-academic fees, and room and board charges.
- b Participant's Travel and Other Personal Expenses Each participating student will be responsible for the payment of his/her own airfare and other personal expenses (e.g., books and material charges).

#### 5 Accommodations

- a Illinois State will make double occupancy rooms available in its International House for exchange students from DongAh. Similarly, DongAh will make residence hall rooms available for students from Illinois State.
- b Students, who choose to live off campus at either institution, will be responsible for finding their own accommodations.


#### 6 Medical Insurance Coverage

- a Participating students are required to show proof of medical insurance upon arrival at either institution.
- b Each participating student's insurance must be valid for the duration of his/her stay in the host country as well as during travel to and from the host country.
- c Participating students may be treated for minor illnesses at the receiving institution's health center.
- d Each participating student will be responsible for the payment of charges related to off-campus medical services, including services provided at private clinics and/or hospitals.


## Article II General Provisions

- 1 The obligations of the parties under this agreement are only for the participating students and do not include spouses or dependents
- 2 Participating students must abide by the laws of the host country and by the rules and regulations of the host university
- 3 This agreement becomes effective when signed by the representatives of the two universities It shall remain in effect for three (3) years unless either university gives a one-year written notice of intent to discontinue
- 4 Any (parts of the) articles in this agreement may be amended or revised by the two universities after consultation and mutual agreement Any such amendment or revision must be in writing and must be signed by the responsible parties as identified below, in item 5 below Any issues not mentioned in this agreement shall be resolved through mutual agreement and each party covenants that it will make good faith efforts to reach such agreement
- 5 The responsible parties for administering this program will be, for Illinois State, the Director of International Studies and Programs and the Chair of the Department of Communication, and for DongAh, the President
- 6 Students admitted under this Articulation Agreement must meet all other graduation requirements at Illinois State University A minimum of 120 semester hours of credit is required in order to graduate
- 7 For two-year institutions, transfer credit is limited to 66 semester hours of academic course work and 4 semester hours of physical education activities
- 8 If either DongAh or Illinois State University change major program requirements, general education requirements, or graduation requirements, the program Articulation Agreement is subject to renegotiation
