Thursday, August 15	Begin final audit on August 2024 bachelor and graduate degree candidates. (If same deficiencies remain from preliminary audit, neither the student nor the department will be contacted. If deficiencies have changed, new statements will be sent to the student and the department/school).
Friday, August 23	Last Day for graduate students planning to receive a graduate degree in December to submit a degree audit and file an application for completion of degree.
Monday, August 26	Proposal approval form (grad school) deadline for December graduates
Friday, September 6	Deadline for submission of materials (late grades, grade changes, transcripts, test scores, petitions for graduation exception, etc.) for August 2024 bachelor degree candidates.
Friday, September 13	Last Day for undergraduate students planning on receiving a degree in December to apply and pay the fee for graduation. Applications may be submitted online through My.IllinoisState.edu.
Monday, September 23	Begin preliminary audit on December 2024 bachelor degree candidates. Deficiency statements will be emailed to students with deficiencies with copies sent to department/school (Electives added to plans and petitions for graduation exception submitted prior to preliminary audit will result in fewer deficiency statements.)

Sunday, August 18	Last day to withdraw from the University and receive a full adjustment of charges. Financial aid will be reduced.

Friday, August 30	Last day to drop a course with no withdrawal grade (WX) assigned and a full adjustment of charges. Financial aid may be reduced. Fall registration closes at 10 p.m. Last day to put a course on audit.
Friday, September 13	Last day to receive 25 percent tuition adjustment for full-semester course withdrawals. There will be no adjustment in charges after this date.
